

- (a) The meetings in which the input of the Provincial Government and its functionaries is required, may be arranged on video-link preferably, so that officers do not have to commute to Islamabad.
- (b) In case personal participation of officers is necessary, such meetings may not be scheduled on Monday and Friday, so that officers do not stay away from their headquarters on long weekends on the pretext of meetings.
- (c) The timings of such meetings may be scheduled with such consideration that participants from provinces need not to stay overnight at Islamabad. The suitable timing for meetings would be between 11.00 a.m. and 5.00 p.m. which will enable the participants to make day trips (to-and-from Islamabad).
