

CIRCULAR

In view to mitigate the difficulties being faced by officers in career progression due to their incomplete PER dossier and lukewarm response from officers, especially retired, to clear the pendency at their end, the Competent Authority has desired that with immediate effect all Inter Departmental Cadre (IDC) and Departmental Cadre (DC) Officers (of Audit Offices) shall render following Undertaking at the time of processing of their pension papers:


1. As a Reporting Officer / Countersigning Officer, no Performance Evaluation Report is pending with me at the moment.
2. Any PER received after my retirement in the capacity of Reporting Officer / Countersigning Officer, shall be actioned upon immediately. And if I do not complete it within one month of being informed of such pendency, I shall have no objection if my pension is suspended till those reports are cleared.
3. The Pension sanctioning authority shall ensure compliance of this Undertaking. In case any PER is pending, the pension shall be sanctioned upon clearance of the pendency.
4. The decision to suspend pension (all IDC & Audit side DC officers) on temporary basis shall be taken by the Auditor-General.
