Subject: ASSISTANCE PACKAGE FOR FAMILIES OF GOVERNMENT  
EMPLOYEES WHO DIED IN SERVICE.

The undersigned is directed to refer the subject cited above and to state that queries and references have been received in this Division that whether a widow who was appointed under Prime Minister's Assistance Package is entitled for extension in contract appointment after remarriage. The issue has been considered in this Division. It is clarified that appointment of a widow of the deceased Government servant is a part of terminal benefits to which a widow is entitled. After remarriage the widow becomes ineligible to receive family pension. Therefore, this Division is of the view that her contract should be terminated from the date of her remarriage. In case, she got married after regularization of her service, she would only be ineligible for pensionary benefits of her earlier deceased husband.
