Subject: - REVISION OF CHARGES FOR PRIVATE USE OF GOVERNMENT VEHICLES

The Federal Government has been pleased to increase the charges for private use of the government vehicle by 100%. The revised rates are as under:-

S#	Type of vehicle	Old rates per kilometer	Revised rates per kilometer
1.	Car / Jeep /Van (upto 5 seater)	Rs. 3/-	Rs. 6/-
2.	Van / station wagon (6 to 14 seater)	Rs. 4/-	Rs. 8/-
3.	Air conditioned Toyota Coaster / equivalent	Rs. 12/-	Rs. 24/-
4.	Non-Air conditioned Toyota Coaster / equivalent	Rs. 8/-	Rs. 16/-
5.	Bus and other heavy duty vehicle used for carrying passengers	Rs. 20/-	Rs.40/-
6.	Mini Trucks/Shehzor for transporting the luggage	Rs. 4/-	Rs. 8/-

2. Ministries/Divisions are requested to circulate the revised rates, for private use of official vehicles, to the Departments and Sub-Ordinate Offices under their administrative control.
