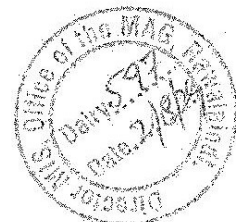

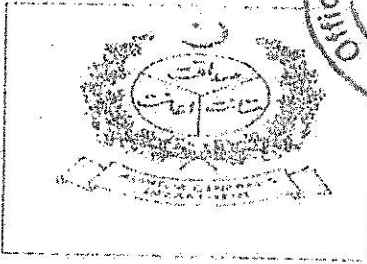


Subject: DECLARATION OF ASSETS HELD AND ACQUIRED BY GOVERNMENT SERVANTS FOR THE YEAR ENDING ON 30<sup>TH</sup> JUNE, 2024.

The undersigned is directed to refer to Rule-12 of the Government Servants (Conduct) Rules, 1964, and administrative instructions issued by the Department of the Auditor-General and Establishment Division through circulars / O.Ms from time to time in previous years along with recent O.M. No.2/1/2013-D-4 dated 10.07.2024 on the above subject. It is, therefore, informed that the Declaration of Income, Assets and Liabilities for the financial year ending on 30<sup>th</sup> June 2024, are required to be furnished by all the officers of Pakistan Audit and Accounts Service serving under your administrative control by 25<sup>th</sup> July, 2024. For this purpose, the prescribed proforma is available on the website "http://www.establishment.gov.pk".

2. Further, as per instructions communicated by the Establishment Division on the subject from time to time, it may also be brought to the notice of all the officers concerned that non-compliance of the above instructions tantamount to "Misconduct" within the meaning of Rule 2(k) of the Civil Servants (Efficiency and Discipline) Rules, 2020. Furthermore, in the light of Rule 7(j) of Civil Servants Promotions (BS-18 to BS-21) Rules, 2019, the civil servants who do not submit his/her annual Declaration of Assets forms, will be deferred from promotion in the respective promotion boards.

3. In view of the above, it is requested that all officers of Pakistan Audit and Accounts Service (PA&AS) working under your administrative control may be directed to ensure submission of their awaited Declaration of Income, Assets & Liabilities including DoAs for the FY 2023-24 by 25<sup>th</sup> July, 2024, if not done already, in compliance with the above referred instructions of the Government.
