Subject: Advisory For Traveling to Attend Out-Station Meetings.

It has been observed that usually officers travel very early in morning to attend out-station meetings in a bid to reach on time. It may be noted that traveling on the same day to attend a meeting scheduled to be held on a different station in early hours of the day increases the chances of fatigue and careless driving thus putting their lives at great risk. A recent fatal accident on motorways is one example.

2. The Auditor General of Pakistan, as cadre administrator, has advised that all officers traveling to the other cities/stations for meetings, scheduled during first half of the day, should reach their destination one day prior to such meetings. It may further be ensured that all passengers sitting in the vehicle even in the back seats are wearing seatbelts (where available).
