Subject: **RE-FIXATION OF PAY (FROZEN ALLOWANCE) ON PROMOTION FROM SA (BPS-16) TO AAO (BS-17)**

It is apprised that MAG office (on request of some AAOs of Controller offices) had taken up the matter with Finance Division Islamabad through Ministry of Defence regarding clarification as to whether the employees who appointed from lower posts/scales to higher posts/ scales by way of promotion are also eligible for the payment of frozen allowances i.e. Audit Accounts Allowance, Disparity Reduction Allowance-2021 & 2022 (frozen at the level of its drawn as on, 30/06/2015, 01/03/2021 & 01/03/2022 respectively) at the initial pay of higher pay scales as admissible to the new entrant who directly appointed in that scales or otherwise.

2. Now Ministry of Defence has shared the clarification/point of view of Finance Division Islamabad on the subject matter under vide U.O. No.8/24/D-7 (MAG)/2023, dated.15/05/2024 (copy attached) for information and necessary action please.

3. This also disposes of CMA (PC) Peshawar letter No.CMA/PC/AN-II/Officer-44812, dated.27/07/2022 & even No. dated.24/11/2022 and CLA (DS) Lahore letter No.CLA/Pay-I/PC-589, dated.25/10/2022.

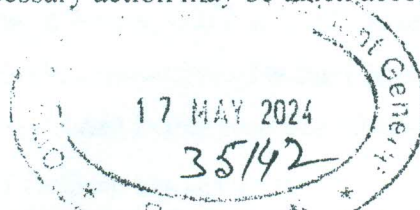
